Heavy landing. Heavy squall came up. The pilot levelled out too high, and becoming confused by relative ground speeds, stalled the a/c several feet above the ground, resulting in a heavy three point landing.

RECOMMENDATIONS:

Unstable air conditions during first solo resulting in heavy landing.

Inexperience and error of judgment.
